A Resolution amending Resolution No. 2021-147 to change the contract period to a one-year agreement with one option to renew for a four-year term, for a professional service contract with AccordWare, LLC for online benefit enrollment services through its BenXpress enrollment system, and to renew said agreement for an amount not to exceed \$484,000.00 for the four-year renewal period, from 8/1/22 through 7/31/26, for the Executive's Department of Human Resources, Division of Employee Benefits, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2021-147, which confirmed the award by the Board of Control (BOC Dir. No. 133-21) of a professional service contract with AccordWare, LLC for online benefit enrollment services through its BenXpress enrollment system, for a one-year term, from 8/1/21 through 7/31/22, for an amount not to exceed \$121,000.00, with four options to renew for additional one-year terms; and

WHEREAS, the parties of said professional services contract wish to lock in the rates in the agreement for the remaining four years, and increase efficiency by obtaining approval for a four-year contract period; and

WHEREAS, the Board of Control, at its meeting held on August 10, 2022, amended its prior Directive 211-22 to change the contract period to a one-year agreement with one option to renew for a four-year term, instead of a one-year agreement with four one-year renewals, for a professional service contract with AccordWare, LLC for online benefit enrollment services through its BenXpress enrollment system, for an amount not to exceed \$484,000.00 for the four-year renewal period, from 8/1/22 through 7/31/26; and

WHEREAS, the Board of Control, at its meeting held August 10, 2022, awarded a renewal (first and final) of a professional service contract with AccordWare, LLC for online benefit enrollment services through its BenXpress enrollment system, for an amount not to exceed \$484,000.00, for the four-year renewal period, from 8/1/22 through 7/31/26, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to amend Resolution No. 2021-147, and to renew the agreement with AccordWare, LLC as amended, for the aforementioned reasons;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

Resolution No. 2021-147 is hereby amended to change the contract period to a one-year agreement with one option to renew for a four-year term, instead of a one-year agreement with four one-year renewals, for a professional service contract with AccordWare, LLC for online benefit enrollment services through its BenXpress enrollment system.
