WHEREAS, in order to continue and further the County's leadership role in creating and implementing a transformative, high functioning, and collaborative economic development system for the region, it is necessary to continue the relationship with Roetzel Consulting Solutions as they are a Best Practical Source due to their expertise in the field and strong knowledge of the County's economic development strategy and initiatives; and

WHEREAS, the Board of Control, at its meeting held August 17, 2022, awarded a professional service contract with Roetzel Consulting Solutions, as a Best Practical Source, to provide economic development strategy, project management and consulting services to the County for the period 9/1/22 through 8/31/23, with two options to renew for additional one-year terms, in an amount not to exceed \$90,000.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned purchase contract with Roetzel Consulting Solutions is necessary and in the best interest of the County of Summit;
