This Ordinance is hereby declared an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit and for the further purpose of immediately amending Section 164A.03 of the Codified Ordinances of the County of Summit in order to ensure that positions on the Development Finance Authority Board can be filled with qualified candidates regardless of their membership on other boards or commissions.
