A Resolution approving the establishment of the classification and classification specification of Deputy Sheriff Cadet, and revising the Sheriff's classified salary schedule to include the classified position of Deputy Sheriff Cadet, Class Code 40075, for the Sheriff and the Executive's Department of Human Resources, and declaring an emergency.

WHEREAS, this Council has the authority pursuant to Article III, Section 3.03(10) of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the Codified Ordinances of the County of Summit to establish classifications and classification specifications for all County employees; and

WHEREAS, the Sheriff wishes to revise her classified salary schedule to include a newly established classified position of Deputy Sheriff Cadet, Class Code 40075, Category C2; Pay Grade 3; and

WHEREAS, the classification of Deputy Sheriff Cadet will be a temporary position designed to encourage recruitment of Deputy Sheriffs, and will be assigned to attend and participate in the University of Akron/Summit County Sheriff's Office Police Academy (the "Academy"); and

WHEREAS, Deputy Sheriff Cadets will be hired as Deputy Sheriffs with the Sheriff's Office upon successful completion of the Academy; and

WHEREAS, at its meeting held on October 19, 2022, at the request of the Executive's Department of Human Resources and the Sheriff, the Human Resource Commission approved the establishment of the classification and classification specification for the non-bargaining classified position of Deputy Sheriff Cadet, Class Code 40075, Category C2; Pay Grade 3, a copy of which is attached hereto as Exhibit A and incorporated fully herein; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, it is necessary and in the best interest of the County of Summit to approve the classification of Deputy Sheriff Cadet, and revise the Sheriff's classified salary schedule to include said classification;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The establishment of the classification and classification specification by the Human Resource Commission, a copy of which is attached hereto as Exhibit A and incorporated fully herein, for the non-bargaining classified position of Deputy Sheriff Cadet is hereby confirmed and approved.
