A Resolution declaring the failure in the gravity main sewer caused by a pipe collapse on Chenoweth Road, located in Springfield Township, in Council District 8, an emergency pursuant to Section 177.07(a)(3) of the Codified Ordinances of the County of Summit, and confirming the award by the Board of Control of a construction contract with Wingfoot Rental & Development Co., in an amount not to exceed \$100,131.58, for an emergency repair to the gravity main sewer, for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.

WHEREAS, due to the failure in the gravity main sewer, emergency repairs were required to replace a collapsed length of pipe in the 18 inch gravity main sewer on Chenoweth Road in Springfield Township; and

WHEREAS, Wingfoot Rental & Development Co. was directed to make the emergency repairs based on their expertise, availability and performance on similar projects; and

WHEREAS, the above referenced circumstances made it necessary for the County to utilize Wingfoot Rental & Development Co. for an emergency repair of the gravity main sewer on Chenoweth Road in Springfield Township, to be returned to normal operations; and

WHEREAS, the Board of Control, at its meeting held on October 19, 2022, awarded a construction contract with Wingfoot Rental & Development Co. for an emergency repair of said gravity main sewer, in an amount not to exceed \$100,131.58, subject to confirmation of this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned repairs constitute an emergency repair under Section 177.07(a)(3) of the Codified Ordinances of the County of Summit and further finds and determines that it is necessary and in the best interest of the County of Summit to confirm the award by the Board of Control of a construction contract with Wingfoot Rental & Development Co. for said emergency repair of the gravity main sewer, in an amount not to exceed \$100,131.58;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

This Council finds and determines that the repair of the gravity main sewer on Chenoweth Road, located in Springfield Township, in Council District 8, is an emergency pursuant to Section 177.07(a)(3) of the Codified Ordinance of the County of Summit.

SECTION 2

The award by the Board of Control of a construction contract with Wingfoot Rental & Development Co. for an emergency repair of the gravity main sewer on Chenoweth Road, located in Springfield Township, in Council District 8, in an amount not to exceed \$100,131.58

SECTION 3

 This Resolution is declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit and for the further reason to immediately authorize a necessary construction contract with Wingfoot Rental & Development Co. for an emergency repair of the gravity main sewer on Chenoweth Road, located in Springfield Township, in Council District 8.

SECTION 4

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 5
