WHEREAS, during root cutting operations in the sanitary sewer on Diana Lynn Drive, in Stow, an equipment mishap occurred when the root grinder became stuck in the pipe and could not be extracted and emergency repairs were required to excavate to the sewer, remove the root grinder, replace the damaged section of pipe and restore the pavement; and

Rental & Development Co., in an amount not to exceed \$62,427.66, for an emergency

repair to the sanitary sewer, for the Executive's Department of Sanitary Sewer Services,

WHEREAS, Wingfoot Rental & Development Co. was directed to make the emergency repairs based on their expertise, availability and performance on similar projects; and

WHEREAS, the above referenced circumstances made it necessary for the County to utilize Wingfoot Rental & Development Co. for an emergency repair of the sanitary sewer on Diana Lynn Drive, in Stow, to be returned to normal operations; and

WHEREAS, the Board of Control, at its meeting held on October 19, 2022, awarded a construction contract with Wingfoot Rental & Development Co. for an emergency repair of said sewer, in an amount not to exceed \$62,427.66, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned repairs constitute an emergency repair under Section 177.07(a)(3) of the Codified Ordinances of the County of Summit and further finds and determines that it is necessary and in the best interest of the County of Summit to confirm the award by the Board of Control of a construction contract with Wingfoot Rental & Development Co. for said emergency repair of the sanitary sewer, in an amount not to exceed \$62,427.66;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

# **SECTION 2**

The award by the Board of Control of a construction contract with Wingfoot Rental & Development Co. for an emergency repair of the sanitary sewer on Diana Lynn Drive, located in the City of Stow, in Council District 3, in an amount not to exceed \$62,427.66 is hereby confirmed and the Executive is hereby authorized to execute said construction contract and any other necessary related documents.
