A Resolution authorizing the Executive to execute an agreement with Cardinal Parking Ltd. for the use by Cardinal of up to 20 parking spaces in the County of Summit Parking Deck for valet service, for one-year, at the rate of \$100.00 per month, for the Executive and declaring an emergency.

WHEREAS, Cardinal Parking Ltd. ("Cardinal") provides valet services at various venues in downtown Akron and has recently been requested by Crave Restaurant to provide valet services for its patrons; and

WHEREAS, in order to support the development of businesses in downtown Akron, the County is willing to permit Cardinal to utilize up to 20 parking spaces in the County of Summit Parking Deck (the "Deck") at the rate of \$100.00 per month for the purposes of their valets parking cars for Crave customers; and

WHEREAS, the monthly rate is different than the ordinary fee charged to other monthly customers of the Deck, who pay \$72.00 per month per section 113.14 of the Codified Ordinances; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute said agreement with Cardinal for valet services at Crave Restaurant;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

The Executive is hereby authorized to execute the agreement with Cardinal Parking Ltd. for a one-year term at the amount of \$100.00 per month for up to 20 parking spaces for valet services to Crave Restaurant.

## **SECTION 2**

This Resolution is hereby declared to be an emergency in the interest of the health, safety and welfare of the residents of the County of Summit and for the further reason that it is necessary to promote business development in Akron.

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
