WHEREAS, this project would be an expansion of the services currently provided by Summit Psychological Associates, Inc. at the Summit County Jail; and

WHEREAS, the Summit County Opiate Abatement Advisory Council has vetted and approved this project and recommends the Executive proceed with implementation; and

WHEREAS, pursuant to sections 177.07(a)(4) and 177.08(a) of the Codified Ordinances of the County of Summit, contracts for professional services with physicians and counselors are exempt from competitive bidding; and

WHEREAS, the Board of Control, at its meeting held October 5, 2022, awarded a professional services agreement with Summit Psychological Associates, Inc., as a Best Practical Source, to provide transitional services for opiate involved individuals at the Jail, for the term of 11/1/22 through 12/31/25, in an amount not to exceed \$1,478,415.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional services agreement is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

 The award by the Board of Control of a professional services agreement with Summit Psychological Associates, Inc., as a Best Practical Source, to provide transitional services for opiate involved individuals at the Jail, for the term of 11/1/22 through 12/31/25, in an amount not to exceed \$1,478,415.00, is hereby confirmed and the Executive is hereby authorized to execute said agreement and any other necessary related documents.
