7 **A Resolution, pursuant to Section 169.04(h) of the Codified Ordinances of the County of**  
8 **Summit, as set forth in Exhibit A, approving and adopting the Report on Staffing for**  
9 **calendar year 2023, for the Executive, and declaring an emergency.**

11 WHEREAS, Section 169.04(h) of the Codified Ordinances of the County of Summit  
12 requires the Executive to submit annually a report on staffing which sets forth the number of full-  
13 time, part-time and seasonal positions within each job classification, that an office, department,  
14 agency, board or commission may employ during the following calendar year; and

16 WHEREAS, the Report on Staffing submitted by the Executive must be adopted by this  
17 Council no later than December 31<sup>st</sup> of each year; and

19 WHEREAS, the Executive has submitted to this Council a Report on Staffing for  
20 calendar year 2023, which is attached hereto as Exhibit A and incorporated herein by reference;

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that it is necessary and in the best interest of the County of Summit to adopt the Report on  
25 Staffing for calendar year 2023;

27 NOW, THEREFORE BE IT RESOLVED, by the Council of the County of Summit, State  
28 of Ohio, that:

32 The Report on Staffing for calendar year 2023, which is attached hereto as Exhibit A and  
33 incorporated herein by reference, is hereby approved and adopted by this Council.

37 This Resolution is hereby declared to be an emergency in the interest of the health, safety  
38 and welfare of the residents of the County of Summit and for the further reason that it is  
39 necessary to immediately approve and adopt the Report on Staffing prior to the deadline  
40 established by the Codified Ordinances of the County of Summit.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take  
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
46 effect and be in force at the earliest time provided by law.
