7 **A Resolution authorizing the Executive, subject to the approval of the Board of Control, to**
8 **execute a purchase contract with Ken Ganley Ford, at less than State Term Pricing, for**
9 **two 2023 Ford F250 pickup trucks, in a total amount not to exceed \$82,222.32, for the**
10 **Engineer, and declaring an emergency.**

11
12 WHEREAS, the Engineer budgets for the periodical purchase of vehicles, equipment and
13 components to replenish worn or past service life equipment and vehicles in order to continue to
14 provide general road maintenance and snow and ice control; and

15
16 WHEREAS, this Council previously adopted Resolution No. 2022-032, which allocated
17 \$450,000.00 in the 2022 Capital Improvements Plan budget for the Engineer to purchase
18 vehicles; and

19
20 WHEREAS, due to supply chain issues the Engineer's Office was unable to locate
21 available pickup trucks until the end of November 2022; and

22
23 WHEREAS, Ken Ganley Ford is offering the Engineer two 2023 Ford F250 pickup
24 trucks for \$4,515.54 less than State Term Pricing per vehicle; and

26 WHEREAS, the Board of Control, at its meeting to be held on December 7, 2022, will
27 consider the aforementioned purchase contract with Ken Ganley Ford; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
31 execute, subject to the approval of the Board of Control, said purchase contract with Ken Ganley
32 Ford;

34 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 The Executive is hereby authorized to execute, subject to the approval of the
40 Board of Control, the purchase contract and any other necessary related documents with Ken
41 Ganley Ford, at less than State Term Pricing, for two 2023 Ford F250 pickup trucks, in a total
42 amount not to exceed \$82,222.32

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the residents of the County of Summit, and for the further reason that the
48 aforementioned purchase contract is immediately necessary to provide needed vehicles for use
49 by the Engineer.
