7 **A Resolution confirming the award by the Board of Control of a two-year purchase**
8 **contract with Rumpke Waste & Recycling Services, with two options to renew for an**
9 **additional two year term, for trash removal and disposal at various County facilities, in an**
10 **amount not to exceed \$313,711.68 for the two year period, for the Executive's Department**
11 **of Finance and Budget – Purchasing, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2022-285, which authorized
14 the Executive to advertise for bids for trash removal and disposal at various County facilities;
15 and

17 WHEREAS, the Board of Control, at its meeting held November 30, 2022, awarded a
18 two-year purchase contract with Rumpke Waste & Recycling Services, with two options to
19 renew for an additional two year term, as the lowest responsive and responsible bidder, for trash
20 removal and disposal at various County facilities, in an amount not to exceed \$313,711.68 for the
21 two year period, subject to confirmation by this Council; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that the aforementioned purchase contract with Rumpke Waste & Recycling Services is
25 necessary and in the best interest of the County of Summit;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

32 The award by the Board of Control of a two-year purchase contract with Rumpke Waste
33 & Recycling Services, with two options to renew for an additional two year term, for trash
34 removal and disposal at various County facilities, in an amount not to exceed \$313,711.68, is
35 hereby confirmed and the Executive is hereby authorized to execute said purchase contract and
36 any necessary related documents.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the residents of the County of Summit, and for the further reason to immediately
42 confirm the award of the aforementioned purchase contract in order to immediately receive trash
43 removal and disposal services.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.
