7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract with Good Life Veterinary Preventative Care for veterinarian services at the**
9 **Animal Control Facility, located in the City of Akron, in Council District 5, for a one-year**
10 **term, in a total amount not to exceed \$104,000.00, for the Executive's Department of**
11 **Administrative Services – Division of Animal Control, and declaring an emergency.**

13 WHEREAS, the Executive's Department of Administrative Services – Division of
14 Animal Control wishes to enter into a professional service contract with Good Life Veterinary
15 Preventative Care for veterinarian services at the Animal Control Facility; and

17 WHEREAS, said services are required for operating the facility including spay and
18 neutering surgeries, rabies vaccinations, prescribing medications and conducting consultations;

21 WHEREAS, the aforementioned contract with Good Life Veterinary Preventative Care,
22 as a professional service contract, is exempt from competitive bidding pursuant to sections
23 177.07(4) and 177.08 of the Codified Ordinances of the County of Summit; and

25 WHEREAS, the Board of Control, at its meeting held January 25, 2023, awarded a
26 professional service contract with Good Life Veterinary Preventative Care for veterinarian
27 services at the Animal Control Facility, located in the City of Akron, in Council District 5, for a
28 one year term, in a total amount not to exceed \$104,000.00, subject to confirmation by this
29 Council; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
32 that the aforementioned contract with Good Life Veterinary Preventative Care is necessary and
33 in the best interest of the County of Summit;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
36 of Ohio, that:

40 The award by the Board of Control of a professional service contract with Good Life
41 Veterinary Preventative Care for veterinarian services at the Animal Control Facility, located in
42 the City of Akron, in Council District 5, for a one-year term, in a total amount not to exceed
43 \$104,000.00, is hereby confirmed and the Executive is hereby authorized to execute said contract
44 and any necessary related documents.

48 This Resolution is hereby declared an emergency in the interest of the health, safety and
49 welfare of the residents of the County of Summit, and for the further purpose of immediately
50 providing continued veterinarian services at the Animal Control Facility.


