WHEREAS, acquisition of lands for public right-of-way for the Project is considered a local cost, which must be borne in whole by the local public agency performing the Project; and

WHEREAS, the County has negotiated terms for agreement for the acquisition of a standard highway easement at 3850 Granger Road in Bath Township, in Council District 5 to serve as the necessary public right-of-way for the Project; and

WHEREAS, this Council has determined, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned agreements for the acquisition of standard highway easements;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;
