7 **A Resolution authorizing the Executive to enter into an agreement for the acquisition of a**
8 **standard highway easement at 3850 Granger Road, located in Bath Township, in Council**
9 **District 5, in a total amount not to exceed \$5,610.00, as part of the Granger Road Bridge**
10 **Replacement Project for the Engineer, and declaring an emergency.**

12 WHEREAS, there is a public need to replace the Granger Road Bridge over Yellow
13 Creek (BAT-079-0221), and the County intends to undertake the Granger Road Bridge
14 Replacement Project, located in Bath Township, in Council District 5 (the "Project"); and

15
16 WHEREAS, certain land must be acquired by the County to be utilized as public right-of-
17 way as part of the Project; and

18
19 WHEREAS, acquisition of lands for public right-of-way for the Project is considered a
20 local cost, which must be borne in whole by the local public agency performing the Project; and

22 WHEREAS, the County has negotiated terms for agreement for the acquisition of a
23 standard highway easement at 3850 Granger Road in Bath Township, in Council District 5 to
24 serve as the necessary public right-of-way for the Project; and

26 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
27 is necessary and in the best interest of the County of Summit to authorize the Executive to
28 execute the aforementioned agreements for the acquisition of standard highway easements;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that;

35 The Executive is hereby authorized to execute an agreement for the acquisition of a
36 standard highway easement at 3850 Granger Road, in Bath Township, in Council District 5, in a
37 total amount not to exceed \$5,610.00, as part of the Granger Road Bridge Replacement Project,
38 with the owner of said property, and in the amount as follows:
