SECTION 1

ENACTED EFFECTIVE

The award by the Board of Control of a construction contract with CATTS Construction, Inc. for the Christman Road Bridge Replacement Project (the "Project"), located in the City of Green, in Council District 8, for a total amount not to exceed \$1,181,236.23, is hereby confirmed, and the Executive is hereby authorized to execute said construction contract and any other necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit, and for the further reason that it will allow the County to proceed with the Project which will replace a structurally deficient bridge over Nimisila Reservoir with an entire new structure.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
