7 **A Resolution confirming the award by the Board of Control of a construction contract with**  
8 **the Petty Group, LLC for the Medical Examiner's Office Fence Installation Project,**  
9 **located in the City of Akron, in Council District 4, in an amount not to exceed \$242,500.00,**  
10 **for the Executive's Department of Administrative Services-Physical Plants Division, and**  
11 **declaring an emergency.**

12  
13 WHEREAS, this Council previously adopted Resolution No. 2022-319, which authorized  
14 the Executive to advertise for bids for the Medical Examiner's Facility Fencing Installation  
15 Project (the "Project") to install an eight foot high perimeter fence around the facility to secure  
16 the building and its occupants, located in the City of Akron, in Council District 4, for an  
17 estimated total cost not to exceed \$174,000.00; and

18  
19 WHEREAS, the Petty Group, LLC submitted the lowest bid, in the amount of  
20 \$242,500.00, for the Project; and

21  
22 WHEREAS, supply chain issues and continued increasing prices for steel and concrete  
23 are the reason for the increase over the estimated total cost used to bid the Project and it is likely  
24 that the cost of this Project will continue to increase which is why the Executive wishes to  
25 proceed with the Petty Group, LLC; and

26  
27 WHEREAS, the Board of Control, at its meeting held on January 18, 2023, awarded a  
28 construction contract with the Petty Group, LCC, as the lowest responsive and responsible  
29 bidder, for the Project, located in the City of Akron, in Council District 4, in an amount not to  
30 exceed \$242,500.00, subject to confirmation by this Council; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that the aforementioned construction contract with the Petty Group, LLC is necessary and in the  
34 best interest of the County of Summit;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
37 of Ohio, that:

41 The award by the Board of Control of a construction contract with the Petty Group, LCC,  
42 for the Medical Examiner's Facility Fencing Installation Project (the "Project"), located in the  
43 City of Akron, in Council District 4, in an amount not to exceed \$242,500.00, is hereby  
44 confirmed, and the Executive is hereby authorized to execute said construction contract and any  
45 other related necessary documents.

49 This Resolution is hereby declared an emergency in the interest of the health, safety and  
50 welfare of the residents of the County of Summit, and for the further reason that it immediately  
51 authorizes a necessary construction contract so that the Project may proceed in a timely and cost  
52 effective manner.




