A Resolution authorizing the Executive to execute an intergovernmental agreement with the University of Akron, to provide up to two beds at the Jail for University of Akron prisoners, for a five-year term, from 1/1/23 through 12/31/27, with four options to renew for an additional five-year term, at a rate of \$123.55 per day per bed for the first year, with a rate increase not to exceed 2.5% per year, for the Executive and the Sheriff, and declaring an emergency.

WHEREAS, the County and University of Akron (the "University") have negotiated an intergovernmental agreement to which the University may use beds in the Jail to house University prisoners, at a maximum of two prisoners per day for a five-year term, from 1/1/23 to 12/31/27, with four options to renew for an additional five-year term; and

WHEREAS, the University has agreed to pay a rate of \$123.55 per day per bed for the first year with a possible increase of up to 2.5% each subsequent year; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned intergovernmental agreement with the University;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

RESOLUTION NO. 2023-038

The Executive is hereby authorized to execute an intergovernmental agreement with the University of Akron, in a form substantially similar to the one attached hereto as Exhibit A, together with any revisions thereto as are not materially adverse to the County, and any other necessary related documents, to provide up to two beds at the Jail for University of Akron prisoners, for a five-year term, from 1/1/23 through 12/31/27, with four options to renew for an additional five-year term, at a rate of \$123.55 per day per bed for the first year, with a rate increase not to exceed 2.5% per year

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of Summit County, and for the further reason to immediately provide beds at the Jail needed by the University of Akron to house its prisoners.
