7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Cargill, Incorporated, at Ohio Department of Transportation Cooperative Purchasing**
9 **pricing, for road salt for the 2023 snow and ice control season, in an amount not to exceed**
10 **\$650,000.00, for the Engineer, and declaring an emergency.**

11
12 WHEREAS, it is necessary for the Engineer to purchase road salt as needed for snow and
13 ice control on County roadways for the remaining 2023 snow and ice control season and, as
14 such, the Engineer's Office budgets annually for the purchase of road salt; and

15
16 WHEREAS, this Council previously adopted Resolution No. 2022-342, which
17 appropriated for said road salt purchases; and

18
19 WHEREAS, Cargill, Incorporated is a contracted supplier under Ohio Department of
20 Transportation Cooperative Purchasing pricing for road salt and pursuant to Section 177.07(a)(9)
21 of the Codified Ordinances of the County of Summit is exempt from competitive bidding; and

23 WHEREAS, the Board of Control, at its meeting held on February 15, 2023, awarded a
24 purchase contract to Cargill, Incorporated, at Ohio Department of Transportation Cooperative
25 Purchasing, for road salt for the 2023 snow and ice control season, in an amount not to exceed
26 \$650,000.00, subject to confirmation by this Council; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that the aforementioned purchase contract with Cargill, Incorporated is necessary and in the best
30 interest of the County of Summit;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The award by the Board of Control of a purchase contract with Cargill, Incorporated, at
38 Ohio Department of Transportation Cooperative Purchasing pricing, for road salt for the 2023
39 snow and ice control season, in an amount not to exceed \$650,000.00, is hereby confirmed and
40 the Executive is hereby authorized to execute said purchase contract and any other necessary
41 related documents.

45 This Resolution is hereby declared an emergency in the interest of the health, safety and
46 welfare of the residents of the County of Summit, and for the further reason to immediately
47 provide for road salt for the 2023 snow and ice control season.


