WHEREAS, the Executive's Department of Job and Family Services ("DJFS") wishes to enter into a Temporary Assistance to Needy Families ("TANF") agreement with Tri-County Jobs for Ohio's Graduates ("JOG") for 2023 Summer Youth Employment Program outreach and eligibility services; and

WHEREAS, under the agreement, JOG will be responsible for employer recruitment, youth job matching, keeping job slots filled, site monitoring, picking up time sheets to be sent to a payroll vendor, general supervision and troubleshooting day-to-day issues; and

WHEREAS, JOG will also be responsible for adhering to reporting requirements, providing oversight of supervisory staff, work readiness skills training and general guidance to youth who are assigned to various work experience sites throughout Summit County; and

WHEREAS, the Board of Control, at its meeting held March 1, 2023, awarded a TANF agreement with JOG, which is exempt from competitive bidding due to the provider's subgrantee status, for 2023 Summer Youth Employment Program outreach and eligibility services, for the period of 4/1/23 through 8/31/23, in an amount not to exceed \$100,000.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that a TANF agreement with JOG is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
