A Resolution confirming the award by the Board of Control of a construction contract with Barbicas Construction Company, Inc. for the 2023 Summit County 441 Asphalt Concrete (448) Resurfacing Program-North, in an amount not to exceed \$3,776,713.75, for the Engineer, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2022-370, which authorized the Executive to advertise, as needed, for bridge engineering and construction projects, and pavement maintenance projects, for the Engineer's 2023 Capital Improvements Program, and federal and state funded projects, for an estimated total cost not to exceed \$13,962,800.00; and

WHEREAS, said projects were approved as part of the Capital Improvements Program for 2023-2028 by Resolution No. 2023-025; and

WHEREAS, following the receipt and review of five bids, the Executive has proposed entering into a construction contract with Barbicas Construction Company, Inc. for the 2023 Summit County 441 Asphalt Concrete (448) Resurfacing Program-North, in an amount not to exceed \$3,776,713.75; and

WHEREAS, the work to be performed by Barbicas Construction Company, Inc. will consist of resurfacing various County, Bath Township, Richfield Township, Sagamore Hills Township and Twinsburg Township roads, including milling, pavement repairs, chip seal prior to resurfacing, an asphalt concrete surface course and new pavement markings; and

WHEREAS, the contract total will be broken down by political subdivision as follows with each subdivision responsible for directly paying the contractor:

County Total: \$960,476.50 OPWC County: \$501,812.00 County Alternate 1: \$61,585.00

Bath Twp: \$186,455.00 Richfield Twp: \$605,277.00

Sagamore Hills Township: \$1,043,579.50

Twinsburg Twp: \$174,907.00

Twinsburg Twp Alternate no. 1: \$154,820.25 Twinsburg Twp Alternate 2: \$87,801.50; and

WHEREAS, the Board of Control, at its meeting held on March 29, 2023, awarded a construction contract with Barbicas Construction Company, Inc., as the lowest responsive and responsible bidder, for the 2023 Summit County 441 Asphalt Concrete (448) Resurfacing Program-North, in an amount not to exceed \$3,776,713.75, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned construction contract with Barbicas Construction Company, Inc. for the

2023 Summit County 441 Asphalt Concrete (448) Resurfacing Program-North is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

## SECTION 1

The award by the Board of Control of a construction contract with Barbicas Construction Company, Inc. for the 2023 Summit County 441 Asphalt Concrete (448) Resurfacing Program-North, in an amount not to exceed \$3,776,713.75, is hereby confirmed and the Executive is hereby authorized to execute said construction contract and any other necessary related documents.

## **SECTION 2**

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further purpose to immediately provide necessary pavement repairs to various County, Bath Township, Richfield Township, Sagamore Hills Township, and Twinsburg Township roads in 2023.

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

## **SECTION 4**

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
