A Resolution confirming the award by the Board of Control of a professional service contract with Ward & Associates for appraisal services for the valuation of commercial, industrial, and exempt buildings considered new or altered, and land splits of the same classification, for the 2023 real estate tax year, in an amount not to exceed \$141,300.00, for the Fiscal Officer, and declaring an emergency.

WHEREAS, Section 177.08 of the Codified Ordinances of the County of Summit states that a professional service contract with appraisers performing services for the Fiscal Officer under Section 5713.01 of the Ohio Revised Code is exempt from the requirements concerning the request and evaluation of proposals as set forth in Section 177.08; and

WHEREAS, Section 177.08 further requires that said professional service contract, when in excess of \$50,000.00, must be approved by this Council; and

WHEREAS, the Board of Control, at its meeting held on March 22, 2023, awarded a professional service contract with Ward & Associates for appraisal services for the valuation of commercial, industrial, and exempt buildings considered new or altered, and land splits of the same classification, for the 2023 real estate tax year, in an amount not to exceed \$141,300.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional service contract with Ward & Associates is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a professional service contract with Ward & Associates for appraisal services for the valuation of commercial, industrial, and exempt buildings considered new or altered, and land splits of the same classification, for the 2023 real estate tax year, in an amount not to exceed \$141,30.00, is hereby confirmed and the Executive is hereby authorized to execute said professional service contract and any necessary related documents.
