7 **A Resolution confirming the award by the Board of Control of a construction contract**  
8 **with Melway Paving Company, Inc., for the 2023 Summit County 405 Resurfacing**  
9 **Program, in an amount not to exceed \$2,197,381.95, for the Engineer, and declaring an**  
10 **emergency.**

11

12 WHEREAS, this Council previously adopted Resolution No. 2022-370, which authorized  
13 the Executive to advertise, as needed, for bridge engineering and construction projects, and  
14 pavement maintenance projects, for the Engineer’s 2023 Capital Improvements Program, and  
15 federal and state funded projects, for an estimated total cost not to exceed \$13,962,800.00; and

16

17 WHEREAS, said projects were approved as part of the Capital Improvements Program  
18 for 2023-2028 by Resolution No. 2023-025; and

19

20 WHEREAS, the work to be performed by Melway Paving Company, Inc. will consist of  
21 resurfacing various County, Bath Township, Coventry Township, Springfield Township and  
22 Village of Peninsula roads, including milling, pulva-mixing, making pavement repairs as  
23 directed by the Engineer and adding of surface course of 405 Bituminous Cold Mix and applying  
24 new pavement markings; and

26 WHEREAS, the contract total will be broken down by political subdivision as follows  
27 with each subdivision responsible for directly paying the contractor:

28

- 29 County share: \$834,156.40
- 30 Bath Township: \$346,089.30
- 31 Coventry Township (including 3 alternates): \$431,864.80
- 32 Springfield Township (including 1 alternate): \$451,146.85
- 33 Peninsula: \$134,124.60; and

35 WHEREAS, following the receipt and review of bids, the Executive proposes entering  
36 into a construction contract with Melway Paving Company, Inc. for the 2023 Summit County  
37 405 Resurfacing Program, in an amount not to exceed \$2,197,381.95, which was under the  
38 Engineer’s estimate; and

40 WHEREAS, the Board of Control, at its meeting held April 12, 2023, awarded a  
41 construction contract with Melway Paving Company, Inc., as the lowest responsive and  
42 responsible bidder, for the for the 2023 Summit County 405 Resurfacing Program, in an amount  
43 not to exceed \$2,197,381.95, subject to confirmation by this Council; and

45 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
46 that aforementioned construction contract with Melway Paving Company, Inc. is necessary and  
47 in the best interest of the County of Summit;

49 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
50 of Ohio, that;

SECTION 1

The award by the Board of Control of a construction contract with Melway Paving Company, Inc., for the 2023 Summit County 405 Resurfacing Program, in an amount not to exceed \$2,197,381.95, is hereby confirmed and the Executive is hereby authorized to execute said construction contract and any other necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further purpose to immediately provide a necessary construction contract for the 2023 Summit County 405 Resurfacing Program.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


