A Resolution confirming the award by the Board of Control, subject to the approval of the Information Technology Board, of a purchase contract with Dell Marketing L.P., at State Term Pricing, for the purchase of perpetual software licenses through Microsoft Select Plus, for the term of 5/1/23 through 9/30/24, in an amount not to exceed \$166,960.61, for the Office of Information Technology, and declaring an emergency.

WHEREAS, perpetual software licenses through Microsoft Select Plus allow the County to use the program indefinitely even if the program is ever limited or discontinued; and

WHEREAS, the Office of Information Technology wishes to purchase perpetual licenses through the Microsoft Select Plus agreement for licensing pertaining to server operating systems, client access licensing, database licensing and other licensing used in our production Microsoft environment and recommends the approval of the purchase contract with Dell Marketing L.P., to accomplish this goal; and

WHEREAS, the Board of Control, at its meeting held on April 26, 2023, awarded a purchase contract, subject to the approval of the Information Technology Board, with Dell Marketing L.P., at State Term Pricing, for the purchase of perpetual software licenses through Microsoft Select Plus, for the term of 5/1/23 through 9/30/24, in an amount not to exceed \$166,960.61, subject to confirmation by this Council; and

WHEREAS, the aforementioned purchase contract will be presented to the Information Technology Board for approval at its meeting to be held on May 25, 2023; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned purchase contract with Dell Marketing L.P., is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control, subject to the approval of the Information Technology Board, of a purchase contract with Dell Marketing L.P., at State Term Pricing, for the purchase of perpetual software licenses through Microsoft Select Plus, for the term of 5/1/23 through 9/30/23, in an amount not to exceed \$166,960.61, is hereby confirmed and the Executive is hereby authorized to execute said purchase contract any other necessary related documents.
