WHEREAS, at its March 16, 2023 meeting, at the request of the Executive's Department of Human Resources the Prosecutor's Child Support Enforcement Agency, the Human Resource Commission approved the upgrading of the classification and classification specification for the non-bargaining classified position of Child Support Assistant Supervisor, Category 2 Pay Grade 4 to Child Support Supervisor, Category 2, Pay Grade 6, as stated in Order 23-02, as set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, it is necessary and in the best interest of the County of Summit to confirm the upgrading of the classification and classification specification by the Human Resource Commission for the non-bargaining classified position of Child Support Assistant Supervisor, Category 2 Pay Grade 4 to Child Support Supervisor, Category 2, Pay Grade 6;
