A Resolution confirming the award by the Board of Control of a construction contract with Barbicas Construction Company, Inc, funded in part by a grant from the Akron Metropolitan Area Transportation Study (AMATS) Resurfacing Program, for the Valley View Resurfacing Project, located in Northfield Center Township, in Council District 1, in an amount not to exceed \$853,468.62, for the Engineer, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2022-370, which authorized the Executive to advertise for bridge engineering and construction projects, and pavement maintenance projects, for the Engineer's 2023 Capital Improvements Program, for an estimated cost not to exceed \$13,962,800.00; and

WHEREAS, the Executive received \$265,000.00 in grant funding from the Akron Metropolitan Area Transportation Study (AMATS) Resurfacing Program for the repair, resurface, and addition of 4-foot-wide shoulders where possible to 0.4 miles of Valley View Road between Olde 8 Road and State Route 8, in Northfield Center Township; and

WHEREAS, following the receipt and review of two bids, the Executive proposes entering into a construction contract with Barbicas Construction Company, Inc., as the lowest responsive and responsible bidder, for the Valley View Resurfacing Project (the "Project"), in an amount not to exceed \$853,468.62; and

WHEREAS, the Board of Control, at its meeting held May 3, 2023, awarded a construction contract with Barbicas Construction Company, Inc., for the for Project, located in Northfield Center Township, in Council District 1, in an amount not to exceed \$853,468.62, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned construction contract with Barbicas Construction Company, Inc., is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

## SECTION 1

The award by the Board of Control of a construction contract with Barbicas Construction Company, Inc., for the Valley View Resurfacing Project (the "Project"), located in Northfield Center Township, in Council District 1,, in an amount not to exceed \$853,468.62, is hereby confirmed and the Executive is hereby authorized to execute said construction contract and any other necessary related documents.
