A Resolution confirming the award by the Board of Control of a construction contract with Karvo Companies, Inc., funded in part by a grant from the Akron Metropolitan Area Transportation Study (AMATS) Resurfacing Program, for the Swartz Road Resurfacing Project, located in Coventry Township, in Council District 8, in an amount not to exceed \$1,028,025.04, for the Engineer, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2022-370, which authorized the Executive to advertise for bridge engineering and construction projects, and pavement maintenance projects, for the Engineer's 2023 Capital Improvements Program, for an estimated cost not to exceed \$13,962,800.00; and

WHEREAS, the Executive received \$500,000.00 in grant funding from the Akron Metropolitan Area Transportation Study (AMATS) Resurfacing Program for the resurfacing and shoulder widening of Swartz Road beginning at S. Main Street and ending at the City of Akron corporation limits near Penguin Drive; and

WHEREAS, following the receipt and review of three bids, the Executive proposes entering into a construction contract with Karvo Companies, Inc., as the lowest responsive and responsible bidder, for the Swartz Road Resurfacing Project (the "Project"), in an amount not to exceed \$1,028,025.04; and

WHEREAS, the Board of Control, at its meeting held May 3, 2023, awarded a construction contract with Karvo Companies, Inc. for the for Project, located in Coventry Township, in Council District 8, in an amount not to exceed \$1,028,025.04, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned construction contract with Karvo Companies, Inc. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

## **SECTION 1**

The award by the Board of Control of a construction contract with Karvo Companies, Inc., for the Swartz Road Resurfacing Project (the "Project"), located in Coventry Township, in Council District 8, in an amount not to exceed \$1,028,025.04, is hereby confirmed and the Executive is hereby authorized to execute said construction contract and any other necessary related documents.
