WHEREAS, said projects were approved as part of the Capital Improvements Program for 2023-2028 by Resolution No. 2023-025; and

WHEREAS, the proposed work calls for the reconstruction of several catch basins throughout Summit County and the associated pavement and curb repair; and

WHEREAS, following the receipt and review of bids, the Executive proposes entering into a construction contract with Spano Brothers Construction, Inc. for the 2023 Summit County Catch Basin Repair Program, in an amount not to exceed \$125,000.00; and

WHEREAS, the contract total will be broken down by political subdivision as follows with each subdivision responsible for directly paying Spano Brothers Construction, Inc.:

County share: None Lakemore: \$7,920.00 Bath Township: \$43,310.00

Sagamore Hills Township: \$62,730.00 Twinsburg Township: \$11,040.00; and

WHEREAS, the Board of Control, at its meeting held May 10, 2023, awarded a construction contract with Spano Brothers Construction, Inc., as the lowest responsive and responsible bidder, for the 2023 Summit County Catch Basin Repair Program, in an amount not to exceed \$125,000.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that the aforementioned construction contract with Spano Brothers Construction, Inc. is necessary and in the best interest of the County of Summit;
