7 **A Resolution declaring Thursday, June 15, 2023 as Elder Abuse Awareness Day in Summit**  
8 **County and encouraging residents to participate in any events and programs designed to**  
9 **raise awareness of and prevent the abuse of older adults, for the Executive, and declaring an**  
10 **emergency.**

11

12 WHEREAS, World Elder Abuse Awareness Day was launched on June 15, 2006 by the  
13 International Network for the Prevention of Elder Abuse and the World Health Organization to  
14 raise awareness of elder abuse and leverage resources to protect older adults; and

15

16 WHEREAS, in February 2012, the Ohio General Assembly passed H.B. 215 naming June  
17 15 as Elder Abuse Awareness Day; and

18

19 WHEREAS, elder abuse includes physical and emotional abuse, neglect, and financial  
20 exploitation that may harm seniors or result in the death of seniors; and

21

22 WHEREAS, elder abuse affects seniors of all socio-economic, racial, and cultural  
23 backgrounds, and occurs across the country and the world in homes, healthcare facilities, offices,  
24 and increasingly online; and

25

26 WHEREAS, an estimated 200,000 older Ohioans face elder abuse annually, but the Ohio  
27 Department of Job and Family Services received only 34,000 calls, suggesting a severe  
28 underreporting of elder abuse across the state; and

29

30 WHEREAS, the perpetrators of elder abuse are not only strangers, but often friends, family,  
31 caregivers, and other people whom seniors rely on for support; and

32

33 WHEREAS, the Executive and this Council are committed to protecting the rights of  
34 seniors in Summit County to live safe, full lives free from abuse, and by raising awareness about  
35 this issue and the resources dedicated to preventing and addressing elder abuse; and

36

37 WHEREAS, the Executive's Department of Job and Family Services continues to raise  
38 awareness about the dangers of elder abuse and neglect through communication campaigns and  
39 collaborations with local organizations; and

40

41 WHEREAS, the Adult Protective Services Program continues to protect older adults in  
42 Summit County by providing or arranging remedies for the abuse, neglect, and or exploitation of  
43 older adults; and

44

45 WHEREAS, the Probate Court and Executive's Office continue to protect older adults by  
46 informing professionals about elder abuse through the annual Senior Summit; and

47

48 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
49 that it is necessary and in the best interest of the County to declare Thursday, June 15, 2023 as  
50 Elder Abuse Awareness Day and to encourage the residents of the County to participate in events  
51 observing that day;

4 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State  
5 of Ohio, that:

7 SECTION 1

8

9 This Council hereby declares Thursday, June 15, 2023 as Elder Abuse Awareness Day and  
10 encourages all the residents and employees of the County to participate in any events and programs  
11 offered in observance of this day.

13 SECTION 2

14

15 This Resolution is hereby declared an emergency in the interest of the health, safety and  
16 welfare of the residents and employees of the County of Summit and for the further purpose of  
17 immediately declaring Thursday, June 15, 2023 as Elder Abuse Awareness Day in Summit  
18 County.

20 SECTION 3

21

22 Provided this Resolution receives the affirmative vote of eight (8) members, it shall take  
23 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect  
24 and be in force at the earliest possible time provided by law.

26 SECTION 4

28 It is found and determined that all formal actions of this Council concerning and relating  
29 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
30 deliberations of this Council and of any of its committees that resulted in such formal action, were  
31 in meetings open to the public, in compliance with all legal requirements, including Section 121.22  
32 of the Ohio Revised Code.
