A Resolution approving the 2023 wage reopener as agreed between the County of Summit, Clerk of Courts and Local 1229 of the American Federation of State, County and Municipal Employees, AFL-CIO (Legal Division of Clerk of Courts), for the third year of the parties' collective bargaining agreement (4/1/23 through 3/31/24), for the Executive and the Clerk of Courts, and declaring an emergency.

WHEREAS, in Resolution No. 2021-189, a collective bargaining agreement ("CBA") and memorandum of understanding was approved between Ohio Council 8 and Local 1229 (Legal Division Clerk of Courts) of the American Federation of State, County and Municipal Employees, AFL-CIO (collectively, the "Union"), and the Executive and the Clerk of Courts (the "County"), for the period 4/1/21 through 3/31/24, with a reopener on wages in the second and third year of the agreement (4/1/22 and 4/1/23); and

WHEREAS, in Resolution No. 2022-250, the wage reopener between the Union and the County for the second year of the CBA was approved, which authorized an increase in pay of two and one-half percent (2.5%); and

WHEREAS, the County and the Union have reached an agreement on the 2023 wage reopener with an increase in pay of four percent (4.0%) in the third year of the CBA (effective 4/1/23); and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to approve the wage reopener between the Union and the Executive and the Clerk of Courts, as agreed between the parties;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## **SECTION 1**

The agreement on the wage reopener between Ohio Council 8 and Local 1229 (Legal Division Clerk of Courts) of the American Federation of State, County and Municipal Employees, AFL-CIO (collectively, the "Union"), and the Executive and the Clerk of Courts (the "County"), for the third year of the collective bargaining agreement, effective April 1, 2023, is hereby approved, authorizing an increase in pay of four percent (4.0%).

## SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit and for the for the further purpose of providing a timely wage increase for Local 1229 (Legal Division Clerk of Courts) of the American Federation of State, County and Municipal Employees, AFL-CIO.
