WHEREAS, at the start of the COVID-19 pandemic, Congress enacted the Families First Coronavirus Response Act (FFCRA), which allowed people to be continuously enrolled in Medicaid programs through the end of the COVID-19 public health emergency, and as part of the Consolidated Appropriations Act, 2023, Congress delinked the continuous enrollment provision, ending continuous enrollment on March 31, 2023; and

WHEREAS, in order to process the high volume of mail coming to the Executive's Department of Job and Family Services as a result of the Consolidated Appropriations Act, 2023, said Department, utilizing its Shared Cost Pool Funds, desires to enter into a contract with Clarity Solutions Group, LLC for services to automate the processing of Medicaid renewal packets received by mail; and

WHEREAS, the Board of Control, at its meeting held on June 21, 2023, awarded a contract to Clarity Solutions Group, LLC, subject to confirmation by Council and the approval of the Information Technology Board, for the above-referenced services; and

WHEREAS, the Information Technology Board, at its meeting to be held July 13, 2023, will consider the aforementioned purchase contract with Clarity Solutions Group, LLC, for approval; and
