WHEREAS, the Executive wishes to enter into a ground lease agreement with Crown Castle, LLC for a cell tower at the Fishcreek Waste Water Treatment Plant, located at 2910 North River Road, Stow, Ohio, in Council District 3. Crown Castle, LLC will pay for the building of the tower and pay the County rent for the tower and a share of the rent for any equipment on the tower from other providers; and

WHEREAS, Crown Castle, LLC. is a Best Practical Source pursuant to Section 177.07(a)(5) of the Codified Ordinances of the County of Summit as they have several such leases with the County and are aware of the County's requirements for cell towers; and

WHEREAS, the Board of Control, at its meeting held July 26, 2023, awarded a Ground Lease Agreement with Crown Castle, LLC, as a Best Practical Source, for a cell tower at the Fishcreek Waste Water Treatment Plant, located at 2910 North River Road, Stow, Ohio, in Council District 3, for a five-year term with nine options to renew for an additional five-year term, for \$12,000.00 for the first year with a yearly 1.5% increase each year thereafter, and 25% of any the rental proceeds received by Crown Castle, LLC from any users or sublessees, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned ground lease agreement with Crown Castle, LLC is necessary and in the best interest of the County of Summit; and
