A Resolution confirming the award by the Board of Control of professional service contract with Direction Home Akron Canton Area Agency on Aging & Disabilities for Adult Protective Services, Liaison and Extreme Chore services from 10/1/23 through 9/30/24, in a total amount not to exceed \$60,000.00, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, the Executive's Department of Job and Family Services seeks to enter an agreement with Direction Home Akron Canton Area Agency on Aging & Disabilities ("Direction Home") for Adult Protective Services ("APS") liaison and extreme chore services; and

WHEREAS, Liaison services will ensure continuity of care for at risk adults and will include comprehensive in-home assessments and individualized health care plans and coordination of the following services: Assisted Living Waiver, Care Coordination, Community Based Care Transitions Program, HOME Choice, information and referrals for community resources, Long Term Care Ombudsman Program, My Care Ohio, Ohio Home Care Waiver and Specialized Recovery Services, disease prevention and wellness promotion programs. Liaison services also include establishing and maintaining case records and data reports, assisting the APS team in decision making to determine the least restrictive environment for clients and court testimony, as needed, for protective/restraining orders and guardianship; and

WHEREAS, Extreme Chore services will address insect and rodent infestations, hoarding situations and post move home cleanouts. Services will also include biohazard cleanup which is often required prior to conducting extermination services; and

WHEREAS, the Board of Control, at its meeting held August 2, 2023, awarded a professional service contract to Direction Home for Adult Protective Services Liaison and Extreme Chore services funded through Title XX from 10/1/23 through 9/30/24, in a total amount not to exceed \$60,000.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information that the aforementioned professional service contract with Direction Home is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

 The award by the Board of Control of a professional service contract Direction Home Akron Canton Area Agency on Aging & Disabilities ("Direction Home") for Adult Protective Services Liaison and Extreme Chore services from 10/1/23 through 9/30/24, in a total amount not to exceed \$60,000.00, is hereby confirmed and the Executive is hereby authorized to execute said professional service contract and any other necessary related documents.
