A Resolution confirming the award by the Board of Control of Change Order No. 5 to a construction contract with North Electric, Inc., for additional work required on the County Lighting Upgrade Project, in an amount not to exceed \$110,747.46, (for a cumulative increase of 36.9%), for a total amount not to exceed \$1,846,097.23, for the Executive's Department Administrative Services—Physical Plants, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2021-352, which authorized the Executive to execute a contract with North Electric, Inc. to complete the County Lighting Upgrade Project ("Project"), installing new lighting in 12 County Buildings, located Countywide, in an amount not to exceed \$1,347,580.00; and

WHEREAS, additional lights, grounding, and tie wires are needed to complete the lighting work and ensure code compliance in various buildings; and

WHEREAS, the Board of Control, at its October 20, 2023 meeting, awarded the above-referenced change order in an amount not to exceed \$110,747.46, (for a cumulative increase of 36.9%), for a total amount not to exceed \$1,846,097.23; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that Change Order No. 5 to the aforementioned contract with North Electric, Inc. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of Change Order No. 5 to a contract with North Electric, Inc. to complete the County Lighting Upgrade Project, in an amount not to exceed \$110,747.46, (for a cumulative increase of 36.9%), for a total amount not to exceed \$1,846,097.23, is hereby confirmed and the Executive is hereby authorized to execute said change order and any other necessary related documents.

SECTION 2

This Resolution is declared an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit and for the further reason to immediately confirm the award of a necessary change order to the contract in order to complete the project.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
