WHEREAS, the Board of Control, at its meeting held on October 11, 2023, awarded a construction contract with Thompson Electric, Inc., as the lowest responsive and responsible bidder, for the Project, in an amount not to exceed \$72,875.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned construction contract with Thompson Electric, Inc. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

 The award by the Board of Control of a construction contract with Thompson Electric Inc. for the Summit County Jail Storage Building Electric Service Project (the "Project"), in an amount not to exceed \$72,875.00, is hereby confirmed and the Executive is hereby authorized to execute said maintenance contract and any other necessary related documents.
