WHEREAS, the County of Summit Clerk of Courts utilizes Federal Express Corporation to perform service of process under certain circumstances; and

WHEREAS, Federal Express Corporation currently provides commercial service of process of documents for the Clerk of Juvenile Court which pursuant to Sections 177.01(h)(4)D. and 177.07(a)(5) of the Codified Ordinances of the County of Summit makes it a Best Practical Source; and

WHEREAS, the cost of service of process is generally paid by parties requesting the service and is recovered through court costs; and

 WHEREAS, the Board of Control, at its meeting held on November 1, 2023, awarded a purchase contract to Federal Express Corporation, as a Best Practical Source, for service of process of documents for the Clerk of Juvenile Court, for a total estimated amount not to exceed \$165,000.00, for a one-year term, for the period of 1/1/24 through 12/31/24; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned purchase contract with Federal Express Corporation is necessary and in the best interest of the County of Summit;
