20	essential baby supplies and parenting information to low-income pregnant people and families
21	parenting children under twelve months of age and will target families living in high infant
22	mortality zip codes; and
23	WHITDEAC the cools of these events one to address essential events inconview and to
2425	WHEREAS, the goals of these events are to address essential supply insecurity, reduce emergency needs and improve infant mortality rates. Items to be distributed include diapers,
26	feeding supplies, basic baby care necessities, child safety items, household cleaning products,
27	parenting materials and resource support information; and

29	WHEREAS, SCPH is already coordinating county-wide diaper bank services for
30	distribution of diapers, wipes and pull-ups to TANF eligible individuals, in collaboration with

34	with SCPH to provide the above referenced services; and
