A Resolution authorizing the Executive and Engineer to apply for Federal Surface Transportation Block Grant funds, Resurfacing Project funds, Transportation Alternatives Set Aside funds, and Carbon Reduction Program funds, programmed by the Akron Metropolitan Area Transportation Study, in order to improve eighteen projects in Council Districts 1, 5, and 8, for the Engineer and declaring an emergency.

WHEREAS, the Akron Metropolitan Area Transportation Study ("AMATS") has issued a notification seeking grant applications for projects eligible to receive Federal Surface Transportation Block Grant ("STBG") funds, Resurfacing Project funds, Carbon Reduction Program ("CRP") funds, and Transportation Alternatives Set Aside ("TASA") funds; and

WHEREAS, the Engineer has identified eighteen different projects in Council Districts 1, 5, and 8 that meet AMATS project criteria and guidelines, with project names and descriptions, a copy of which is attached hereto as Exhibit A and incorporated fully herein; and

WHEREAS, the federal programs will provide up to 80% or 95% of the construction costs for the projects, depending on the program; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive and Engineer to apply for STBG, Resurfacing, and TASA funds programmed by AMATS to improve eighteen projects in Council Districts 1, 5, and 8;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The Executive, on behalf of the County of Summit, are hereby authorized to apply for Federal Surface Transportation Block Grant funds, Resurfacing Project funds, and Transportation Alternative Set Aside funds programmed by the Akron Metropolitan Area Transportation Study ("AMATS") for eighteen projects identified in Exhibit A, a copy of which is attached hereto and incorporated fully herein.

SECTION 2

That the County of Summit acknowledges and understands the AMATS "Funding Policy Guidelines" and confirms to the best of its knowledge that the information contained in the project application is accurate, that it intends to diligently pursue that project, and that a local share is required to match federal funds.

SECTION 3

The Clerk of Council is instructed to provide two certified copies of this Resolution to the Engineer, for submission to AMATS as part of the funding applications.
