7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract with The Great Life Spay Neuter Wellness fka Good Life Veterinary Preventative**
9 **Care, LLC for veterinarian services at the Animal Control Facility, located in the City of**
10 **Akron, in Council District 5, for a one-year term, for the period 4/1/24 to 3/31/25, in a total**
11 **amount not to exceed \$114,400.00, for the Executive’s Department of Administrative**
12 **Services – Division of Animal Control, and declaring an emergency.**

14 WHEREAS, the Executive’s Department of Administrative Services – Division of
15 Animal Control wishes to enter into a professional service contract with The Great Life Spay
16 Neuter Wellness fka Good Life Veterinary Preventative Care, LLC (“The Great Life Spay
17 Neuter Wellness”) for veterinarian services at the Animal Control Facility; and

19 WHEREAS, said services are required for operating the facility including spay and
20 neutering surgeries, rabies vaccinations, prescribing medications, setting up treatment protocols
21 and conducting consultations; and

23 WHEREAS, the aforementioned contract with The Great Life Spay Neuter Wellness, as a
24 professional service contract, is exempt from competitive bidding pursuant to sections 177.07(4)
25 and 177.08 of the Codified Ordinances of the County of Summit; and

27 WHEREAS, the Board of Control, at its meeting held November 29, 2023, awarded a
28 professional service contract with The Great Life Spay Neuter Wellness for veterinarian services
29 at the Animal Control Facility, located in the City of Akron, in Council District 5, for a one-year
30 term, for the period 4/1/24 to 3/31/25, in a total amount not to exceed \$114,400.00, subject to
31 confirmation by this Council; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that the aforementioned contract with The Great Life Spay Neuter Wellness is necessary and in
35 the best interest of the County of Summit;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that:

46 hereby confirmed and the Executive is hereby authorized to execute said contract and any




