7 **A Resolution authorizing the Executive to execute a collective bargaining agreement**
8 **between Ohio Council 8 and Local 1229 of the American Federation of State, County and**
9 **Municipal Employees, AFL-CIO (Executive’s Office Unit), and the Executive for the**
10 **period 4/1/23 through 3/31/26, for the Executive, and declaring an emergency.**

12 WHEREAS, a collective bargaining agreement has been reached between Ohio Council 8
13 and Local 1229 of the American Federation of State, County and Municipal Employees, AFL-
14 CIO (Executive’s Office Unit), and the Executive, for the period 4/1/23 through 3/31/26, with an
15 increase in pay of four percent (4.0%) in the first year of the agreement (4/1/2023), then for the
16 second year (4/1/2024) and third year (4/1/2025) of the agreement, revised hourly rates for each
17 classification have been established based on an analysis of external and internal comparable
18 wages; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that it is necessary and in the best interest of the County to authorize the Executive to execute the
22 aforementioned collective bargaining agreement;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that:

27 SECTION 1

29 The Executive is hereby authorized to execute a collective bargaining agreement between
30 Ohio Council 8 and Local 1229 of the American Federation of State, County and Municipal
31 Employees, AFL-CIO (Executive’s Office Unit), and the Executive, for the period 4/1/23
32 through 3/31/26, with an increase in pay of four percent (4.0%) in the first year of the agreement
33 (4/1/2023), then for the second year (4/1/2024) and third year (4/1/2025) of the agreement,
34 revised hourly rates for each classification have been established based on an analysis of external
35 and internal comparable wages.

39 This Resolution is hereby declared an emergency in the interest of the health, safety, and
40 welfare of the residents of the County of Summit and for the for the further purpose of providing
41 a timely collective bargaining agreement between Local 1229 of the American Federation of
42 State, County and Municipal Employees, AFL-CIO (Executive’s Office Unit), and the
43 Executive.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.


