7 **A Resolution authorizing the Executive to advertise for bids for the Legal Department**
8 **Renovation Project, for the Summit County Children Services Administration Building,**
9 **located in the City of Akron, in Council District 4, for an estimated amount not to exceed**
10 **\$300,000.00, for the Executive’s Department of Administrative Services–Physical Plants,**
11 **and declaring an emergency.**

13 WHEREAS, the Administration Building for Summit County Children Services
14 (“SCCS”), located at 264 S Arlington St, Akron, Ohio, in Council District 4, was built in 1996;
15 and

16

17 WHEREAS, the Administrative Building’s current layout of for their Legal Department
18 is from the original building construction and requires much needed renovations; and

19

20 WHEREAS, the Legal Department Renovation Project (the “Project”) will dramatically
21 improve staff efficiency, comfort and productivity for their Legal Department; and

22

23 WHEREAS, the Executive wishes to undertake the Project to improve working
24 conditions and prolong the serviceability of the SCCS Administration Building; and

26 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
27 requires this Council’s authorization for the Executive to advertise for bids; and

29 WHEREAS, the Executive wishes to advertise for bids for the aforementioned Project,
30 for an estimated total cost not to exceed \$300,000.00; and

32 WHEREAS, a copy of the bid specifications for the Project is on file in the Clerk of
33 Council’s Office; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
36 that is necessary and in the best interest of the County of Summit to authorize the Executive to
37 advertise for bids for the Project, for estimated total costs not to exceed \$300,000.00; and

39 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
40 of Ohio, that:

44 The Executive is hereby authorized to advertise for bids for the Legal Department
45 Renovation Project (the “Project”), for the Summit County Children Services (“SCCS”)
46 Administration Building, located in the City of Akron, in District 4, for an estimated total cost
47 not to exceed \$300,000.00.
