7 **A Resolution confirming the award by the Board of Control of a professional service contract**
8 **with Greenleaf Family Center, as a Best Practical Source, to provide assessments to identify**
9 **individuals who may require enhanced Court services through the Summit County Targeted**
10 **Community Alternatives to Prison program, from 1/1/24 through 6/30/24, with an option to**
11 **renew the agreement for an additional six months, for a total term not to exceed one year, in**
12 **an amount not to exceed \$100,000.00 per six month term, for the Executive’s Department of**
13 **Public Safety, and declaring an emergency.**

15 WHEREAS, the State of Ohio Department of Rehabilitation and Correction (“ODRC”) previously awarded Community Corrections Act (“CCA”) 407 and 408 program grants, to support housing and alternative community correction programming for felony and misdemeanor offenders; a Targeted Community Alternatives to Prison (“TCAP”) grant, to assist in housing felony 4 and 5 offenders locally, in lieu of transferring them to state prison; and a Justice Reinvestment and Incentive Grant, which provides programming to offenders to reduce recidivism; and

23 WHEREAS, ODRC has combined these grant programs for the two-year grant cycle for State Fiscal Years 2024-2025 into the Community Corrections Act 2.0 grant; and

26 WHEREAS, under the CCA 2.0 grant program, ODRC awarded a grant in the amount of \$7,597,903.00 to the County of Summit, for the period 7/1/23 through 6/30/25, with no local cash match requirement to support maintaining offenders locally and being able to provide alternative community corrections housing and programming; and

31 WHEREAS, this grant funding is provided to Greenleaf Family Center to provide court assessments for the Court of Common Pleas to identify individuals who may benefit from enhanced court services; and

35 WHEREAS, the initial term of this agreement shall be from 1/1/24 through 6/30/24, with an option to renew the agreement for an additional six months, for a total term not to exceed one year; and

39 WHEREAS, Greenleaf Family Center is a Best Practical Source pursuant to Sections 40 177.01(h)(4) and 177.07(a)(5) of the Codified Ordinances of the County of Summit as they 41 currently provide court assessment services for the Court of Common Pleas since 2017 as well as 42 providing similar assessment services for various Summit County agencies and courts since 2009; 43 and

45 WHEREAS, the Executive wishes to enter into a professional service contract with the 46 Greenleaf Family Center to provide said programs and services to individuals; and

48 WHEREAS, the Board of Control, at its meeting held January 17, 2024, awarded the 49 aforementioned professional service contract with Greenleaf Family Center, as a Best Practical 50 Source, from 1/1/24 through 6/30/24, with an option to renew the agreement for an additional six 51 months, for a total term not to exceed one year in an amount not to exceed \$100,00.00 per six 52 month term, subject to confirmation by this Council; and

4 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
5 that the aforementioned professional service contract with Greenleaf Family Center is necessary
6 and in the best interest of the County of Summit;

8 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
9 of Ohio, that:

11 SECTION 1

13 The award by the Board of Control of a professional service contract with Greenleaf Family
14 Center, as a Best Practical Source, to provide court assessments to identify individuals who may
15 require enhanced Court services, from 1/1/24 through 6/30/24, with an option to renew the
16 agreement for an additional six months, for a total term not to exceed one year, in an amount not
17 to exceed \$100,000.00 per six month term, is hereby confirmed and the Executive is hereby
18 authorized to execute said professional service contract and any other necessary related documents.

22 This Resolution is hereby declared an emergency in the interest of health, safety, and
23 welfare of the residents of the County of Summit, and for the further reason to immediately
24 continue to provide court assessments without interruption, effective 1/1/24.

28 Provided this Resolution receives the affirmative vote of eight members, it shall take effect
29 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and
30 be in force at the earliest time provided by law.

34 It is found and determined that all formal actions of this Council concerning and relating
35 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
36 deliberations of this Council and of any of its committees that resulted in such formal action, were

38 121.22 of the Ohio Revised Code.
