7 **A Resolution authorizing the Executive to execute an Intergovernmental Agreement with**  
8 **the City of Akron for the boarding at the Summit County Jail of misdemeanor offenders**  
9 **charged under a City of Akron ordinance or charged with contempt of an Akron**  
10 **Municipal Court Judge, for a term of one-year, from January 1, 2024 to December 31,**  
11 **2024, in an amount not to exceed \$4,928,697.00, for the Executive and Sheriff, and**  
12 **declaring an emergency.**

13

14 WHEREAS, since 1993, the County has boarded certain City of Akron offenders charged  
15 with misdemeanor offenses under a City of Akron ordinance or charged with contempt of an  
16 Akron Municipal Court Judge pursuant to an Intergovernmental Agreement with the City of  
17 Akron; and

18

19 WHEREAS, in 2018, this Council passed resolution 2018-229 authorizing the Executive  
20 to execute a five-year Intergovernmental Agreement with the City of Akron that ended on  
21 December 31, 2023; and

23 WHEREAS, the Executive and Sheriff have negotiated a new Intergovernmental  
24 Agreement with the City of Akron for the boarding at the Summit County Jail of misdemeanor  
25 offenders charged under a City of Akron ordinance or charged with contempt of an Akron  
26 Municipal Court Judge, for a term of one-year, from January 1, 2024 to December 31, 2024, in  
27 an amount not to exceed \$4,928,697.00, a copy of which is attached hereto as Exhibit A and  
28 incorporated herein by reference; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
31 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
32 execute the aforementioned Intergovernmental Agreement;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
35 of Ohio, that:

37 SECTION 1

39 The Executive is hereby authorized to execute an Intergovernmental Agreement with the  
40 City of Akron for the boarding at the Summit County Jail of misdemeanor offenders charged  
41 under a City of Akron ordinance or charged with contempt of an Akron Municipal Court Judge,  
42 for a term of one-year, from January 1, 2024 to December 31, 2024, in an amount not to exceed  
43 \$4,928,697.00, a copy of which is attached hereto as Exhibit A and incorporated herein by  
44 reference, with such modifications and revisions as shall be in furtherance of the provisions of  
45 said agreement, and not substantially adverse to the County, all of which shall be conclusively  
46 evidenced by the execution thereof by the Executive.

50 This Resolution is hereby declared an emergency in the interest of the health, safety and  
51 welfare of the residents of Summit County, and for the further reason to immediately authorize

7 Agreement.

11 Provided this Resolution receives the affirmative vote of eight members, it shall take  
12 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
13 effect and be in force at the earliest time provided by law.

17 It is found and determined that all formal actions of this Council concerning and relating  
18 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
19 deliberations of this Council and of any of its committees that resulted in such formal action,

21 121.22 of the Ohio Revised Code.
