WHEREAS, the Executive’s Department of Job and Family Services (“DJFS”) wishes to enter into a Temporary Assistance to Needy Families (“TANF”) agreement with Emmanuel Christian Academy for Science Technology Engineering Arts and Math (“STEAM”) Summer Enrichment Camp Services for kindergarten through 8th grade students; and

WHEREAS, services provided will include academic, social and personal enrichment opportunities designed to reinforce STEAM concepts learned during the school year, expand general knowledge and social skills, and challenges students for the upcoming school year; and

WHEREAS, Emmanuel Christian Academy, in collaboration with Summit Education Initiative, will assess students at the start and end of the program to determine its academic effectiveness; and

WHEREAS, the Executive wishes to enter into a TANF agreement with Emmanuel Christian Academy to provide the above referenced services; and

WHEREAS, the Board of Control, at its meeting held February 28, 2024, awarded a TANF agreement with Emmanuel Christian Academy, which is exempt from competitive bidding due to the provider’s subgrantee status, to provide STEAM Summer Enrichment Camp Services for kindergarten through 8th grade students, from 4/1/24 through 9/30/24, in an amount not to exceed \$100,000.00, subject to confirmation by this Council; and
