8 **A Resolution confirming the award by the Board of Control of a Temporary Assistance to**
9 **Needy Families agreement with Tri-County Jobs for Ohio’s Graduates (JOG) for 2024**
10 **Summer Youth Employment Program outreach and eligibility services, for the period of**
11 **4/1/24 through 8/31/24, in an amount not to exceed \$125,000.00, for the Executive’s**
12 **Department of Job and Family Services, and declaring an emergency.**

14 WHEREAS, the Executive’s Department of Job and Family Services (“DJFS”) wishes to
15 enter into a Temporary Assistance to Needy Families (“TANF”) agreement with Tri-County Jobs
16 for Ohio’s Graduates (“JOG”) for 2024 Summer Youth Employment Program outreach and
17 eligibility services; and

19 WHEREAS, under the agreement, JOG will be responsible for employer recruitment,
20 youth job matching, keeping job slots filled, site monitoring, picking up time sheets to be sent to
21 a payroll vendor, general supervision and troubleshooting day-to-day issues; and

23 WHEREAS, JOG will also be responsible for adhering to reporting requirements,
24 providing oversight of supervisory staff, work readiness skills training and general guidance to
25 youth who are assigned to various work experience sites throughout Summit County; and

26

27 WHEREAS, the Board of Control, at its meeting held February 28, 2024, awarded a
28 TANF agreement with JOG, which is exempt from competitive bidding due to the provider’s
29 subgrantee status, for 2024 Summer Youth Employment Program outreach and eligibility
30 services, for the period of 4/1/24 through 8/31/24, in an amount not to exceed \$125,000.00,
31 subject to confirmation by this Council; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that the aforementioned TANF agreement with JOG is necessary and in the best interest of the
35 County of Summit;

37 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
38 of Ohio, that:

42 The award of a Temporary Assistance to Needy Families (“TANF”) agreement with Tri-
43 County Jobs for Ohio’s Graduates for 2024 Summer Youth Employment Program outreach and
44 eligibility services for the period of 4/1/24 through 8/31/24, in an amount not to exceed
45 \$125,000.00, is hereby confirmed and the Executive is hereby authorized to execute said TANF
46 agreement and any other necessary related documents.

50 This Resolution is hereby declared an emergency in the interest of the health, safety and
51 welfare of the residents of Summit County, and for the further reason to immediately approve the
52 necessary TANF agreement to provide summer youth employment outreach and eligibility
