7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Montrose Auto Group, as a Best Practical Source, for seven 2023 Dodge Police Interceptor**
9 **Utility Vehicles, in a total amount not to exceed \$293,622.46, for the Sheriff, and declaring**
10 **an emergency.**

11

12 WHEREAS, the Sheriff budgets for the periodical purchase of equipment and vehicles to
13 replenish worn or past service life equipment and vehicles for use by the Sheriff’s Office; and

14

15 WHEREAS, this Council previously adopted Resolution No. 2024-028, which allocated
16 funds for replacement vehicle purchases in the 2024 Capital Improvements Plan budget for the
17 Sheriff’s Office; and

18

19 WHEREAS, due to high demand for such vehicles and low inventory nationwide is has
20 been extremely difficult for the Sheriff to locate necessary law enforcement vehicles for her fleet
21 and due to the current market conditions vehicle manufacturers are not selling these vehicles at
22 State Term or Public Cooperative Purchasing pricing; and

23

24 WHEREAS, the Sheriff requires replacement vehicles for her fleet and her office
25 identified Montrose Auto Group as a dealership with available vehicles for said purpose;
26 however, due to the aforementioned demand and limited inventory, dealerships are not holding
27 vehicles and therefore the Sheriff is requesting First Reading Passage of this resolution; and

29 WHEREAS, as stated above, the Sheriff’s Office identified Montrose Auto Group as the
30 only dealership with available vehicles which pursuant to Sections 177.01(h)(4)D. and
31 177.07(a)(5) of the Codified Ordinances of the County of Summit makes them a Best Practical
32 Source; and

34 WHEREAS, the Board of Control, at its meeting held on March 13, 2024, awarded a
35 purchase contract with Montrose Auto Group, as a Best Practical Source, for seven 2023 Dodge
36 Police Interceptor Utility Vehicles, in a total amount not to exceed \$293,622.46, subject to
37 confirmation by this Council; and

39 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
40 that the aforementioned purchase contract with Montrose Auto Group is necessary and in the
41 best interest of the County of Summit;

43 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
44 of Ohio, that:

48 The award by the Board of Control of a purchase contract with Montrose Auto Group, as
49 a Best Practical Source, for seven 2023 Dodge Police Interceptor Utility Vehicles, in a total
50 amount not to exceed \$293,622.46, is hereby confirmed and the Executive is hereby authorized
51 to execute said purchase contract and any other necessary related documents.
