7 **A Resolution authorizing the Executive to advertise for bids for the purchase of a Tri-Axle**  
8 **Dump Trailer, for an amount not to exceed \$88,000.00, for the Executive’s Department of**  
9 **Sanitary Sewer Services, and declaring an emergency.**

11 WHEREAS, a Tri-Axle Dump Trailer is a critical piece of equipment for the Department  
12 of Sanitary Sewer Services, and they are utilized for the daily operations of the Department and  
13 are critical in maintaining service to our customers, to properly maintain our sewers and for  
14 meeting permit requirements; and

15

16 WHEREAS, the Tri-Axle Dump Trailer will be utilized for the hauling of sludge,  
17 transport of materials and other purposes during sewer mainline repairs and rehabilitation; and

18

19 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
20 requires this Council’s authorization for the Executive to advertise for bids; and

21

22 WHEREAS, the Executive wishes to advertise for bids for the purchase of a Tri-Axle  
23 Dump Trailer, for an amount not to exceed \$88,000.00; and

25 WHEREAS, a copy of the bid specifications for the purchase of a Tri-Axle Dump Trailer  
26 is on file in the Clerk of Council’s Office; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
30 advertise for bids for the aforementioned purchase of the Tri-Axle Dump trailer, for an amount  
31 not to exceed \$88,000.00;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
34 of Ohio, that:

38 The Executive is hereby authorized to advertise for bids for the purchase of a Tri-Axle  
39 Dump Trailer for the Department of Sanitary Sewer Services to be utilized for the Department’s  
40 daily operations throughout the County, for an amount not to exceed \$88,000.00.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and  
45 welfare of the residents of the County of Summit, and for the further reason that it authorizes the  
46 Executive to immediately advertise for bids for the purchase of a necessary trailer for the  
47 Department of Sanitary Sewer Services.
