7 **A Resolution authorizing the Executive to execute a lease agreement with Akron Soul**
8 **Train, an Ohio non-profit, for property located at 191 South Main Street, Akron, Ohio**
9 **44308, in Council District 4, for educational and/or charitable use, for a three-year term,**
10 **from 5/1/24 through 4/30/27, with two options to renew for a one-year term, for the amount**
11 **of \$1.00 per year, for the Executive, and declaring an emergency.**

13 WHEREAS, the County of Summit owns local real property located at 191 South Main
14 Street, Akron, Ohio 44308, part of Parcel No. 6753253, located in Council District 4; and

15

16 WHEREAS, Akron Soul Train, an Ohio non-profit corporation, offers artist residency
17 programs that provide resources for all creative disciplines, with the purpose to foster a more
18 vibrant downtown Akron; and

20 WHEREAS, this Council previously adopted Resolution 2019-114 which authorized the
21 Executive to execute a five-year lease agreement for the lease of a portion of the building at the
22 aforementioned address to Akron Soul Train; and

23

24 WHEREAS, the Executive wishes to lease County-owned real property to Akron Soul
25 Train upon such terms and conditions as set forth in Exhibit A, attached to this Resolution and
26 incorporated as if rewritten herein, for a three-year term and two options for one-year renewals;
27 and

29 WHEREAS, pursuant to Section 177.17(e) of the Codified Ordinances of the County of
30 Summit, approval by the Board of Control is not required and only the approval of this Council
31 is necessary for the Executive to execute the proposed lease agreement because the lessee is a
32 non-profit corporation that will lease the space for educational and/or charitable purposes; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
36 execute a lease agreement with Akron Soul Train as set forth in Exhibit A;

38 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
39 State of Ohio, that:

41 SECTION 1

43 The Executive is hereby authorized to execute a lease agreement with Akron Soul Train,
44 an Ohio non-profit, for property located at 191 South Main Street, Akron, Ohio 44308, in
45 Council District 4, for educational and/or charitable use, for a three-year term, from 5/1/24
46 through 4/30/27, with two options to renew for a one-year term, for the amount of \$1.00 per
47 year. The lease agreement shall be in substantially the same form as set forth in Exhibit A,
48 attached to this Resolution and incorporated herein as if fully restated.

13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
14 effect and be in force at the earliest time provided by law.

18 It is found and determined that all formal actions of this Council concerning and relating
19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
20 deliberations of this Council and of any of its committees that resulted in such formal action,
21 were in meetings open to the public, in compliance with all legal requirements, including Section
22 121.22 of the Ohio Revised Code.


