7 **A Resolution declaring the month of May 2024 as Foster Care Month in the County of**
8 **Summit and encouraging residents to join in this acknowledgement and consider the**
9 **importance of foster care in their community, for the Executive, and declaring an emergency.**

11 WHEREAS, since 1988, Foster Care Month has been recognized by the U.S. Department
12 of Health and Human Services (DHHS) Children’s Bureau in order to raise awareness, support
13 children in foster care, and show appreciation for foster families; and

14

15 WHEREAS, the theme of Foster Care Month this year is “Engaging Youth. Building
16 Supports. Strengthening Opportunities.” which centers on authentic youth engagement, the
17 importance of lifelong connections, and how to best support youth as they transition out of foster
18 care; and

19

20 WHEREAS, in the United States, there are over 463,000 children and youth in foster care,
21 including over 850 children and youth in the care of Summit County Children Services (SCCS);
22 and

23

24 WHEREAS, SCCS works hard to support these children and place them with foster
25 families when they cannot safely be with their own family and

26

27 WHEREAS, there are 138 foster families in Summit County that deserve our appreciation
28 to their commitment and care for children and youth; and

29

30 WHEREAS, while these families have stepped up, there is a need for more foster families,
31 as the current number is not enough to support the children under the care of SCCS who prioritizes
32 keeping children in their own neighborhood and schools when possible; and

34 WHEREAS, Foster parents are a vital part of the SCCS team that helps to provide services
35 to children and families; and

36

37 WHEREAS, Foster parents provide a loving, safe and nurturing home for children as long
38 as they are placed in their care; and

40 WHEREAS, Foster parents work with biological families to help them in their efforts with
41 reunification; and they work with SCCS to meet the child’s needs and support the birth family.

43 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
44 of Ohio, that:

48 The month of May 2024 is hereby declared Foster Care Month in Summit County and the
49 residents of Summit County are encouraged to join in this acknowledgement by raising awareness
50 about foster care, support children in foster care, showing appreciation toward foster families, and
51 considering fostering children in the future.

19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
20 deliberations of this Council and of any of its committees that resulted in such formal action, were

22 of the Ohio Revised Code.




