15 16 17 18 19	WHEREAS, the theme of Foster Care Month this year is "Engaging Youth. Building Supports. Strengthening Opportunities." which centers on authentic youth engagement, the importance of lifelong connections, and how to best support youth as they transition out of foster care; and
20 21 22 23	WHEREAS, in the United States, there are over 463,000 children and youth in foster care, including over 850 children and youth in the care of Summit County Children Services (SCCS); and
24 25 26	WHEREAS, SCCS works hard to support these children and place them with foster families when they cannot safely be with their own family and
27 28 29	WHEREAS, there are 138 foster families in Summit County that deserve our appreciation to their commitment and care for children and youth; and
30 31 32 33	WHEREAS, while these families have stepped up, there is a need for more foster families, as the current number is not enough to support the children under the care of SCCS who prioritizes keeping children in their own neighborhood and schools when possible; and
34 35 36	WHEREAS, Foster parents are a vital part of the SCCS team that helps to provide services to children and families; and
37 38 39	WHEREAS, Foster parents provide a loving, safe and nurturing home for children as long as they are placed in their care; and
40 41 42	WHEREAS, Foster parents work with biological families to help them in their efforts with reunification; and they work with SCCS to meet the child's needs and support the birth family.
