A Resolution confirming the award by the Board of Control of a purchase contract with Ports Petroleum Company, Inc. for unleaded and diesel fuel for general fleet operations, at CUE pricing, for a ten-month term, from 3/25/24 through 12/31/24, in an amount not to exceed \$300,000.00, for the Engineer, and declaring an emergency.

WHEREAS, the Engineer's Office budgets annually for purchases of fuel, and in its 2024 general operating budget previously adopted by this Council in Resolution No. 2023-354, \$300,000.00 was appropriated for said fuel purchases; and

WHEREAS, Ports Petroleum Company, Inc. is a contracted supplier under CUE pricing for diesel and unleaded fuels and pursuant to Section 177.07(a)(8) of the Codified Ordinances of the County of Summit is exempt from competitive bidding; and

WHEREAS, the Board of Control, at its meeting held on April 24, 2024, awarded a purchase contract to Ports Petroleum Company, Inc., at CUE pricing, for unleaded and diesel fuel for general fleet operations, for a ten-month term, from 3/25/24 through 12/31/24, in an amount not to exceed \$300,000.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned purchase contract with Ports Petroleum Company, Inc. for unleaded and diesel fuel for general fleet operations is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a purchase contract with Ports Petroleum Company, Inc. for unleaded and diesel fuel for general fleet operations, at CUE pricing, for a ten-month term, from 3/25/23 through 12/31/24, in an amount not to exceed \$300,000.00, is hereby confirmed and the Executive is hereby authorized to execute said purchase contract and any other necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit, and for the further reason to immediately provide unleaded and diesel fuel for general fleet operations at the Engineer's Office.
